Internships at Tate

Our internship programme aims to offer structured work-based learning opportunities to support career development and to open up opportunities for working in the arts sector.

Previous experience of working in a museum or gallery is not a requirement to undertake an internship at Tate. Our aim is to attract people to join us as interns who might not have thought about working in our sector before or who have not had the opportunity to experience what this might be like. We want to offer these opportunities to those people who would benefit most from an internship at Tate both in terms of furthering their personal or professional development and who, in return, would have a new and different perspective to bring to our work.

Through our internship programme we want to open up working to Tate to people from all backgrounds and increase the diversity of our workforce. We encourage applications from those from black, ethnic minority and disabled applicants as these groups are currently underrepresented in our sector.

Internships in our Exhibitions and Art Handling Department

Our Exhibitions and Art Handling department at Tate Liverpool is an exciting place to be. We create a series of special exhibitions and collection displays, to showcase the best in contemporary and modern international art. Many of our exhibitions and displays also tour other venues, nationally and internationally.

An opportunity has arisen for an Exhibitions and Displays Intern to support our forthcoming programme, and gain hands-on experience at the heart of our curatorial processes.

During your internship you will have the opportunity to participate in some of the most exciting curatorial work nationally and internationally in a really stimulating environment. This will in turn give you a number of formal and informal learning opportunities that will assist you with your future career.

What this internship will give you the opportunity to do and learn

By the end of your internship you will be able to:

- Assist on loan paperwork and administration for upcoming winter 2019 exhibitions, opening December 2019 (*Theaster Gates* and *Vivian Suter*), and assist in the loan research and request process for further exhibitions in the future programme
- Maintain TMS (The Museum System) exhibition records for *Theaster Gates and Vivian Suter*, and contribute towards similar records for exhibitions in the future programme
- Work with the Senior Curator, Curator and Assistant Curators to support the delivery and installation of *Theaster Gates* and *Vivian Suter* by assisting with installation planning and development, researching and producing print material for the exhibitions' interpretation, and shadowing the Curator and Assistant Curator during the exhibitions' installation period in Tate Liverpool's fourth floor and Wolfson galleries.
- Undertake training in TMS, Excel and Sketch Up.

To support you to acquire the skills and experience above you will have the opportunity to learn about and undertake the following activities and tasks:

To apply for the Internship you will need to

- Demonstrate that you will benefit from the opportunity and how it will help you to build a better future.
- Be willing to learn
- Be enthusiastic and have a 'can do' attitude
- Be dependable, work hard and be committed to getting the job done
- Have the ability to communicate clearly
- Work well with other people and as part of a team
- Be adaptable and flexible when dealing with different tasks
- Be able to think clearly, respond calmly when problems arise and contribute to solutions
- Make a commitment for the whole internship placement
- Have an interest in modern and contemporary art
- Have good attention to detail

What we are offering

The internship opportunity is available for a period of 3 months commencing in September 2019.

You will be required to work 3 days (21.6 hours) per week for the duration of the internship.

You will receive an allowance paid at the rate of £9.00 per hour in accordance with the UK Living Wage.

For the duration of your internship you will be entitled to accrue paid holiday on a pro rata basis to the full time equivalent of 28 working days paid holiday per year. This is inclusive of bank holidays.

Other benefits include:

- Subsidised staff catering arrangements and discounts in the Tate Restaurants and Cafes.
- Access to Tate Benefits which offers access to discounts in high street stores.
- Access to a 24/7 Employee Assistance Programme to support you with any work, personal or family issues. This includes telephone-based support, as well as comprehensive online resources.

- Free entry to paying exhibitions at Tate Galleries. Opportunities for family and friends to visit the major exhibitions out–of-hours.
- Discounts on items purchased in the Tate shops.
- Free access to a number of other galleries and museums throughout the UK on production of a valid staff pass.
