About the role

You will join the team as a Conservation Workshop Technician within the Paintings, Frames & Workshop team, providing technical support across all areas of Tate's programmes spanning displays and exhibitions, loans, acquisitions, collection care and International Partnerships Programme. Day-to-day, you will work closely with colleagues in the Conservation Workshop to

care for, handle, prepare and maintain artworks and their associated components for safe storage, transit, installation and display.

About your team

The Paintings, Frames and Workshop Conservation team treats a broad range of artworks and enjoys being creative and pragmatic, providing solutions and collaborating with colleagues. They work proactively across all programme areas including International Partnerships, Loans, Acquisitions, Exhibitions and Displays and Collection Care.

The Conservation department sits within the Collection Care division and provides specialist conservation expertise to support the programme, and care for Tate's Collection. Specialist areas include Time-based media, Paintings, Frames and Workshop, Sculpture and Installation Art, Paper and Photographs, Conservation Science and Preventive Conservation. Working together, the department brings excellence and innovation to the care of Tate's Collection, preventing damage and deterioration and ensuring that the Collection is available for future generations to enjoy.

What you will gain

Motivated and skilled people are key to our continued success, and we want everyone at Tate to have the opportunity to develop and thrive. In this team, you will be encouraged to contribute your ideas, realise your potential, and learn new skills and knowledge.

What you will do

You will provide carpentry and technical support and expertise support for the conservation, preservation and use of works of art in Tate's collections and care. You will work flexibly together with colleagues in the Conservation Workshop across all areas of programme activity including International Partnerships, Loans, Acquisitions, Exhibitions and Displays and Collection Care.

Main Responsibilities

Provide carpentry and technical support for the conservation of artworks in Tate's collection

- To carry out the manufacture of artworks supports for paintings, sculpture, paper e.g. stretchers, panels, looms and scaffolds to support sculptures.
- To build stable environments for artworks according to design
- To carry out the manufacture of new and reproduction frames.
- To undertake the adaptation of historic frames according to Conservation standards.
- To complete appropriate Conservation documentation of work carried out on artworks in Tate's Collection.
- Assist senior conservation technicians or conservators in the preparation of artworks e.g. canvas stretching, or carrying out maintenance operations under the supervision of conservators or senior conservation technicians.
- Advice to staff on all areas of technical requirements for the artworks in Tate's Collection and Care.
- To carry out specialist technical assistance on design, joinery materials and structural stability of support materials for artworks.

Collections Care and Preventive Conservation Activity

- Assist Senior Technicians in reducing risks and rates of deterioration with the design and development of accessories or modifications to artworks to maintain and improve standards of storage, installation, display and transport.
- Assist with preventive conservation activities such as environmental monitoring, integrated pest management and maintenance of artworks on display.
- Maintain an organised workplace including equipment maintenance and workshop machinery as required.

Provide technical support for Tate programmes

- Provide accurate time estimates for activities undertaken.
- To participate in the design and to construct cases for travel and storage of artworks.
- Create and document display specifications and associated activity.
- To participate in the design and to construct gallery display furniture.
- To be knowledgeable regarding display and preventive conservation requirements
- To assist with gallery installations.
- To complete documentation of work to support Tate programmes, by maintaining work process documentation (documentation includes digital photography).
- Support workplace activity and implement required Health and Safety measures.
- Undertake courier activity and oversee transport and installation of art works at Tate and non-Tate sites (training will be provided as needed).

Supervision and Training

- Participate in training for Tate staff, supervision of interns/apprentices as required.
- Support the Conservation management team in reviewing, improving and implementing procedures and policies.

Public and Professional Activities

- Develop and update expertise through Continuing Professional Development.
- Share knowledge and expertise with colleagues.

What you will bring to the team

Essential

- A City & Guilds qualification in carpentry and joinery or cabinet making or equivalent
- Certified experience in the use of Industrial Wood and Metal Machinery and other specialised Workshop equipment to include use and maintaining hand and power tools
- Able to demonstrate a broad range of developed craft skills including carpentry, metalworking and machine maintenance
- Able to work effectively as part of a team or alone with effective interpersonal and communication skills
- Effective time management, with the ability to work well under pressure

- An adaptable and flexible approach to work, with practical and pragmatic approach to problem solving
- Good observation skills, with attention to detail

Desirable

- Experience of working with a range of structural materials including wood, metal and plastics
- Basic knowledge of the COSHH regulations and requirements
- Good IT skills including experience with core Microsoft packages.
- Experience in the safe handling of artworks
- Relevant First Aid qualification or willingness to train.
- Willingness to acquire a sound working knowledge of contemporary and traditional art manufacturing processes
- Interest and commitment to the work of Tate
- Museum experience
